Bike Path Progress – (Steve G.)

All Buildings are demolished in the annex.
Money should be available for paving and signage to link the rail trail from Rout 3A to the park visitor center and campground.
Suggestion was made to get signage on the MBTA Greenbrush Line advertising the rail trail.
There are plans for a “Grand Opening” of the rail trail in the near future.
The main focus after the Landmine Classic will be on creating new trails through the annex.

Trail Care – (Dave F.)

Bike Barn Trail Day repaired trail in pit area and made a lot of progress but more work needs to be done in this area.
All of the holes in South Field have been filled in.
Several blow downs need to be removed. Steve has list and will take care of removal.
Jack’s store is interested in doing a trail day at Wompatuck. They would like to put in banks along the pine run and will bring in material and supply a work crew.
